



Donate your tax credits



Did you know that you can increase your support of Child Cancer Foundation at no extra cost to you? By donating the tax credits for donations you have made in the past, you will be able to make an even greater difference for Kiwi children and whānau whose lives have been turned upside down by childhood cancer.

Our partners at Charity Booster can make the claim on your behalf – simply enter your details and they will do the rest for you!

What is Charity Booster?

For New Zealand taxpayers, each donation made above \$5 is eligible for a 33% tax credit. In 2014, less than 50% of Kiwis claimed back their tax credits following a donation. Today, it is estimated that over \$300 million each year is left unclaimed with the IRD, and Charity Booster want to change this.

How does it work?

You may already be aware that donations made to any New Zealand charity can qualify for an IRD refund. While you might have claimed this yourself in the past, why not donate it instead?

With the help of Charity Booster, you can now donate your tax credits to Child Cancer Foundation. This can be done with any donation over \$5 you have made in the past four years. Whether or not the initial donation was made to Child Cancer Foundation, the tax credits can be donated to us.

Register online

In order to claim your donation from the IRD we need to confirm your personal details and collect your IRD number.

You can find your IRD Number on your payslips, KiwiSaver statement, by logging into My IR, or by calling 0800 277 774

Crunching numbers

We will track down your donation tax receipts so you don't have to, and confirm your donation amount.

You can boost your original donation amount by up to 33% by donating your tax credits. These funds will go a long way to help Kiwi kids fighting cancer around the country.

Processing

We will lodge your donation claim with the IRD and let you know once your donation is received.

Please note that IRD processing can take up to six weeks. We will make sure to touch base with you again once your donation is received.

Why donate to Child Cancer Foundation?

Finding out your child has cancer turns your life upside down. It happens to more than three Kiwi families every week. None of them ever thought it would happen to their child.

Cancer doesn't care about these children or their families. Child Cancer Foundation does. We support them every step of the way, whatever the outcome, for however long it takes.

We focus on the whānau, not the cancer. No two families' experiences are the same, and neither is the nature of the support they need. One thing is always the same, though. We support every family to concentrate on the most important thing of all: loving and caring for their child.
